like maize, sorghum soyabean, pulses, cocounut, clove and spices;

- (c) whether Government are planning a phase-out schedule for lifting import curbs on farm goods; and
- (d) if so, what are the safeguard provisions?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (DR. S. VENUGOPALACHARI): (a) and (b) Government of India implementing a number of Central Centrally Sponsored Programmes to help the farmers in improving the quality and productivity of crops, so as to reduce cost of production to enable them to face international competition. These include Integrated Cercal Development Programmes Coarse Cereals, Wheat and Rice, Intensive Cotton Development Programme, Special Jute Development Programme, Sustainable Development of Sugarcane based Cropping System. Accelerated Cereal Development Programme Maize, Oilseeds Production Programme. National Development Programme and Integrated Programme for Development of Spices and schemes implemented through the Coconut Development Board.

(c) and (d) India has recently presented to World Trade Organisation (WTO) a plan for the elimination of all residual Quantitative Restrictions on imports including those of agricultural products which are currently maintained for balance of Payments purposes. It is proposed to remove the Quantitative Restrictions on several agricultural items such as apple, oranges, cabbage, grapes WTO etc. There are consistent safeguards measures in the form of tariffs, bound rates, anti-dumping and countervailing measures to prevent damage to domestic production through surge in imports.
