The GSI has undertaken gold investigation during the last 3 years (1994-1997) in the States of Karnataka. Maharashtra. Madhya Pradesh. Andhra Pradesh. Orissa. Kerala, Tamil Nadu, Uttar Pradesh, Rajasthan. Sikkim. West Bengal, Andaman Island, Bihar, Assam and Meghalaya.

State Govt. of Orissa have also informed that M/s OMC have filed three applications for grant of Mining Leases in Gandhamardan Bauxite deposit area.
