F.M. Radio Station/HPTV Station at Junagadh in Gujarat

- 740. SHRI ANANTRAY DE-VSHANKER DAVE: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:
- (a) whether any decision has been taken on the Gujarat Government's request for setting up of a F.M. Radio Station and a HPTV Station at Junagadh so far;
 - (b) if not, the details thereof; and
- (c) if not, the reasons therefor and how long it will take for Government to come to a decision in the interest of vast area of Saurashtra region of the State?

THE MINISTER OF INFORMATION AND BROADCASTING (SHRI S. JAIPAL REDDY): (a) to (c) Yes, Sir, There is a proposal to set up a Relay Centre with 5 KW FM Transmitter, Playback Facilities and a High Power TV Transmitter in place of the existing Low Power TV Transmitter at Junagadh during 9th Plan period. However, implementation of the proposal will depend upon availability of adequate funds, other in-frastructural facilities, and relative priorities.

Criteria for Advertisements

The Advertising Policy takes into account target area, circulation, readership as well as budgetary provisions to achieve the objectives of the advertisement released.
- (c) Quality of newspaper, in addition to circulation, is also taken into consideration for achieving the goal of reaching the target population effectively.

Composition of the Proposed Media Council

- (a) what will be the composition of the proposed Media Council;
