

(c) To resolve this matter, an inter-departmental committee was constituted by this Ministry. Based on the recommendations of the committee export of formulations of the said species by the exporters was allowed for a period of 90 days from 28.8.1997 to clear the existing stock of formulations. Further extension of time upto 31 March 98, by which time the revised Export-Import Policy will become effective, is also being considered. In addition, the Botanical Survey of India has been asked to carry out review of the status of the 53 plants, which have been put on the negative list of exports, in consultation with all concerned and make specific recommendations in the matter.

#### **Defects in Current Examination System**

(b) if so, the brief details of the suggestions made;

(d) the brief details of unaccepted suggestions and reasons for their non-acceptance?

THE MINISTER OF STATE IN THE DEPARTMENT OF EDUCATION IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MUHI RAM SAIKIA): (a) to (d) A meeting was convened on 27th June, 1997 to discuss various issues including those relating to examination reforms in the Secondary Education Sector. Some Members of Parliament, Heads of educational institutions and Principals of a few schools were among those who participated in the meeting. As a follow up of the discussions held in the meeting, a Working Group has been constituted for bringing about transparency in examinations and evaluation. The Group is yet to submit its report.
