SHRI E. BALANANDAN: Mr. Vice-Chairman, Sir, I seek your protection. *(Interruptions)* He is a big leader. *...(Interruptions)*

THE VICE-CHAIRMAN (SHRI ADHIK SHIRODKAR): Mr. Balanandan, I am sorry. We have to take up the Private Members' Business now. We will continue after 5 p.m. You have to stop now.

SHRI E. BALANANDAN: I will stop. Sir. I will say only one thing. Sir, ours is a secular country. We have Christians. We have Muslims. We have Hindus. We have other communities. Many schools are being run by the minority communities. Is it proper that they should be attacked? Physical forces are used. A school is attacked and the Bible is being burnt. Is it in line with our secular character? Does it mean that Bible cannot be used in a school? I would request Mr. Rajagopal. Instead of shouting at me *...(Interruptions)* he should tell his Government to see that such things do not happen in this country. *(Interruptions)*

THE VICE-CHAIRMAN (SHRI ADHIK SHIRODKAR): Mr. Rajagopal, please sit down.

SHRI O. RAJAGOPAL: This is happening everywhere. *(Interruptions)*

SHRI E. BALANANDAN: You should heed the warning from me. Such a thing cannot be tolerated in India, which is a secular country.

Thank you, Sir.

THE VICE-CHAIRMAN (SHRI ADHIK SHIRODKAR): Now we have to take up the Private Members' Business. The rest of the Members on this would be called after 5 p.m.

SHRI RAJUBHAI A. PARMAR (Gujarat): Sir, my name is there.

SHRI RAJUBHAI A. PARMAR: I want to associate myself with this. It happened in my State.
