in the region to-some extent contributed to the slow progress of work.

(c) The progress of construction of new terminal complex and that of runway works at Lilabari is 17% and 32% respectively as on 30.4.98. These works are likely to be completed by July, 99.

Development of Civil Aviation in North-Eastern Region

606. SHRI PARAG CHALIHA: Will the Minister of CIVIL AVIATION be pleased to state:

- (a) the details of steps, if any, taken/ contemplated by Government for a rapid development of civil aviation in the States of the North-Eastern region;
- (b) whether any Action Plan has been prepared by Government, therefore;
 - (c) if so, the details thereof; and
 - (d) if not, the reasons therefor?

THE MINISTER OF **CIVIL** AVIATION (SHRI ANANTH KUMAR): (a) to (d) With a view to achieving better regulation of air transport seivices and taking into account the need for air transport services of different regions in the country, the Government has laid down the Route Dispersal Guidelines. Accordingly, every operator operating any scheduled air transport services within the country is required to provide at least 10% of the capacity deployed on trunk routes (Category-1) to stations connecting the North-East region, J & K, Andaman & Nicobar and Lakshadweep (Category-H). A proposal to provide incentives to further develop air services to North Eastern region is also under consideration, which envisages providing subsidy and other incentives to the operators for operating services this in region. Development/upgradatioi. of airports at Agartala, Guwahati, Imphal, North Lakhimpur, Silchar, and Tezpur is in progress.

Post Offices and Telegraph Offices in Gujarat

607. SHRI DILIP SINGH JUDEV: Will the Minister of COMMUNICATIONS be

- (a) the number of post offices and telegraph offices under the Gujarat (Ahmedabad) circle modernised during 1994-95 and 1996, till now;
 - (b) the expenditure incurred thereon;

- (d) whether criteria has been followed strictly while awarding contracts; and
- (e) if not, the reasons therefore and the action taken by Government in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI KABINDRA PURKAYASTHA): (a) In 1994-95, 7 Post Offices, 24 Telegraph Offices and 33 Combined offices were modernised. From the year 1995-96. till now 90 post offices, 6 telegraph offices and 30 combined offices have been modernised.

- (b) An expenditure of about Rs. 4.46 crores has been incurred thereon.
- (c) The selection of contractors was done through the "Open Tender" System.

 - (e) Does not arise.

Talks on Demands of Private Basic **Operators**

608.SHRI **RAMDAS** AGARWAL: Will the Minister of COMMUNICATIONS be pleased to state:

(a) whether Government recently held talks with the private basic operators and as a result thereof DOT (Department of Telecommunications, has agreed for certain concessions in order to give impetus to the slow progress of the

privatisation of telephone services in the country;

- (b) if so, what are the demands of the basic operators and how many of them have signed licence agreement with the DOT so far; and
- (c) what concrete steps DOT has taken so far to seek help at inter-State level in order to sort out the difficulties at the Government levels?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI KABINDRA PURKAYASTHA): (a) Discussions have been held with private basic operators for reviewing the progress of implementation of their projects. Efforts are being made to sort out the difficulties pointed out by them by coordinating with various State Government and Central Departments such as expeditious permission for laying of cables along highways and on forest land. No concession beyond the terms conditions of Licence has been offered.

- (b) The Association of Basic Telecom Operators has demanded shifting of effective date of licence by one year and also the extension of licence period from 15 years to 25 years. Six private companies have signed the licence agreements with Department of Telecom.
- (c) Meetings have been held at Secretary's level with the Ministerics of Surface Transport and Environt & Forests to sort out the burning problem of Right of way faced by the licensees in the implementation of their projects. Chief Secretaries of the respective State Governments have also been addressed demiofficially to extend necessary cooperation in this regard.

Telephones Out of Order in Pauri Garhwal, Uttar Pradesh

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI KABINDRA PURKAYASTHA): (a) The number of villages in Pauri Garhwal Distt. connected with telephone facility within last three years is 138.

- (b) Due to difficult and hilly terrain, some times repair of faulty telephones is delayed. All efforts are made by concerned officers to make arrangements for repair.
- (c) The village telephone No. 4627 at Bara P.O. Pesoli, Patti-Edwalsuon, Distt. Pauri Garhwal is at present disconnected due to non payment w.e.f. 30.3.98. The number has been in working condition for last one year with some interruptions due to open wire line for about 5 kms.
- (dj The VPT at Bara would be restored as soon as the dues arc paid.
