Production of Silk in North-Eastern Region

878. SHRI PARAG CHALIHA: Will the Minister of TEXTILES be pleased to state the details of the steps taken in the preceeding five years to promote production, processing and trading of silk in Assam and other States of North-Eastern Region?

THE MINISTER OF TEXTILES (SHRI KASHIRAM RANA): In Order to supplement efforts of the State Sericulture Department, the Central Silk Board (CSB) is implementing a large number of schemes/projects/programmes for promoting development of all the 4 types of silk. These includes schemes for extension of R&D training, infrastructure extension support to the sector through a net work of CSB units and implementation of certain development/ investments/financial assistance schemes for encouraging adoption of modern sericulture practices for production of quality silk. Besides CSB also takes up specific sericulture project like World Bank assisted NSP, Action Plan for the North Eastern states etc., in association/ collaboration with the States. As far as Assam and other States of North Eastern states are concerned some of the specific projects taken up by CSB during the VHIth Five Year Plan are as follows:

- (i) Under the National Sericulture Project which was implemented in two districts in Assam infrastructure facilities were created such as basic seed farms, technical service centres. Cocoon markets, demonstration cum training centre for reelers and weavers, etc.
- (ii) North Eastern Action Plan covering Assam and other States of the North Eastern region in presently under implementation which provides assistance towards increase in acreage by plantation, training to farmers, reelers, setting up of cocoon training facilities and assistance for setting up of reeling units, etc. This project is being continued during the IXth Plan period.
 - (iii) Assistance is extended to the agencies for marketing various cocoons.
 - (iv) Project development and domestic marketing for Eri and Muga.

- (v) Muga raw-material sale depot was set up at Guwahati.
- (vi) To boost the production of silk 34 Catalytic Development Schemes have been sanctioned for the IXth Plan period.

Tourist potential in Kerala

- 879. SHRI VAYALAR RAVI: Will the Minister of TOURISM be pleased to state:
- (a) whether Government are aware that tourist potential is very good in Kerala and it has not been fully exploited; and
- (b) if so, what steps have taken to expand tourist facilities in collaboration With State Government?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM (SHRI OMAK APANG): (a) Yes, Sir.

(b) Financial assistance has been provided to the Government of Kerala for the implementation of several projects to expand tourist facilities in the State. The amounts sanctioned to the State Government during the last three years are as given below:—

- (d) the number of places identified for tourism in North-Eastern States?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM (SHRI OMAK APANG): (a) The tax revenue earned by the Central Government by way of expenditure tax during 1996-97 and 1997-98 is Rs. 293.23 crores and Rs. 277.91 crores respectively.

(b) to (d) The identification and development of tourist centres is primarily the responsibility of state/UT Governments. However, proposals are received from time to time for the inclusion of certain tourist centres in the circuits identified for intensive development. Such proposals were received from the State Governments of Kerala, Assam, Arunachal Pradesh and Himachal Pradesh during 1997-98.

The circuit consisting of Guwahati-Kaziranga-Shillong-Tawang was included during 1997-98 in the circuits for intensive development. All the centres in the circuit are in North East.
