## Construction of Short-stay Homes and Working Womens Hostels

The sanction of new Short Stay Homes has been temporarily stopped at present on account of proposal for revised norms & guidelines under consideration of the Government.

*Working Women's Hostels:* No new proposal for construction of Working Women's Hostel in the Capital is pending in the Department of Women & Child Development.

To develop scientific temperament and personality of rural youth.
