Supply of Sugar through PDS

2008. SHRI DRUPAD BORGOHAIN: Will the Minister of FOOD AND CONSUMER AFFAIRS be pleased to state:

(a) whether it is a fact that supply of sugar through PDS will run out from mid-July this year;

(b) if so, the reasons therefor; and

(c) Government's plan to revive it?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD AND CONSUMER AFFAIRS (SHRI SATYA PAL SINGH YADAV): (a) to (c) No, Sir. With the carry over stocks of the last season 1996-97 and the estimated production of sugar during the current sugar season 1997-98, the Central Government have already made allocations of levy sugar for Public Distribution System till August, 1998.

**Adverse effects of Vanaspati import from
Nepal**

(a) whether Government are aware that Vanaspati units in Eastern region are adversely affected on account of import of Vanaspati from Nepal under Indo-Nepal Treaty, as the imported Vanaspati is much cheaper in comparison with the indigenous production; and

(b) whether Government propose to amend the said Treaty so as to save the domestic industry; and if so, by when and if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD AND CONSUMER AFFAIRS (SHRI SATYA PAL SINGH YADAV): (a) Yes, Sir.

(b) The matter is being taken up with the Government of Nepal in the contest of the provisions of the Treaty.

**Measures for Controlling Prices of
Essential Commodities**

(a) whether Government are aware that the prices of pulses, edible oils and other essential commodities have increased manifold since the past few months:

(b) if so, whether Government have totally failed to check the prices of essential commodities; and

(c) if so, the reasons therefor and further action Government propose to take to bring down the prices of essential commodities?

THE MINISTER OF CHEMICALS AND FERTILIZERS AND THE MINISTER OF FOOD (SHRI SURJIT SINGH BARNALA): (a) A statement showing the percentage variation in the wholesale price index of pulses, edible oils and certain other essential commodities for the last three months is enclosed. (See below).

(b) and (c) The Government has accorded the highest priority to the control of prices of essential commodities. Apart from certain long term measures to increase the production of essential goods, imports under Open Gen-
