Agreement for closer Indo-US Defence

925. SHRIMATI VEENA VERMA: Will the PRIME MINISTER be pleased to state:

- (a) whether during the recent visit of a US-delegation fed by President Bill Clinton's Special Envoy Mr. Richardson, any agreement or understanding has been reached for closer Indo-US defence ties:
 - (b) if so, the details thereof; and
- (c) the steps taken and being taken in pursuance thereof?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL **AFFAIRS** (SHRIMATI VASUNDHARA RAJE): (a) to (c) The visit of the delegation led by Ambassador, Bill Richardson, US Permanent Representative to UN from April 14-15, 1998 was in the context of the broad-based dialogue in which the United States and India have been engaged for the last several months. As part of this process, Indo-US defence cooperation activities which have been proceeding under the 1995 "Agreed Minutes of Defence Relations between India and the United States," were also discussed. These involve service-toservice cooperation activities, training etc., as well as cooperation in a Joint Technology Group on research and development. No new agreement was signed during the visit.

US Intervention in between India and Pakistan

926. SHRI NILOTPAL BASU: SHRI E. BALANANDAN:

Will the PRIME MINISTER be pleased to state:

(a) whether Government have made complaint to the US Government recently about the proliferation of weapon by Pakistan; and

(b) if so, what is the justification for inviting outside power like the US to intervene instead of dealing with Pakistan at the regional level?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRIMATI VASUNDHARA RAJE):
(a) and (b) Pakistan has a long-standing programme to acquire nuclear weapons and missiles through clandestine procurement and transfers from outside. Government has made known its legitimate security concerns to all concerned including the United States.

Government has also made it clear that there is no scope for outside interference in bilateral matters.
