Proposals to lay synthetic tennis courts in Lucknow and Allahabad

1123. SHRI RAJNATH SINGH 'SURYA' Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether it is a fact that proposals tolay synthetic tennis courts in Lucknow and Allahabad in Uttar Pradesh and to replace astroturf of Sports Colleges, Lucknow are pending with Government;

- (c) whether Government have fulfilled its financial and other obligations in this regard; and
 - (d) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SUSHREE UMA BHARATI): (a) to (c) No such fresh proposals are pending with Government. Earlier, proposals for laying synthetic tennis courts in Lucknow and Allahabad were received during March, 1995 and these were approved with financial assistance of Rs. 8.46 lakh each. Out of this, Rs. 5.00 lakh for each project have been

released to the Government of Uttar Pradesh. The remaining amount of Rs. 3.46 lakh for each project will be releasd to them after completion of the projects and submission of progress reports and Utilisation Certificates for the amounts already released. However, no proposal for replacement of astroturf of Sports College, Lucknow has been received.
