THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (DR. MURLI MANOHAR JOSHI): (a) and (b) Yes, Sir. A separate DPEP Bureau was created in the Ministry of Human Resource Development (Department of Education) to primarily deal with the Centrally Sponsored and externally aided scheme of District Primary Education Programme (DPEP) in 1994. The DPEP Bureau serves to appraise, finance and supervise the State and District plans according to the prescribed procedures and DPEP Guidelines, to assist the General Council and the Project Board of the DPEP Mission which has been set up in the Ministry .for the implementation of the programme in a mission mode, to release funds to the State Implementation Societies and seek reimbursements from the external funding agencies, to ensure compliance of the financial agreements reached with the various multilateral/ bilateral funding agencies to look after the supervision, monitoring and evaluation aspects of the project, overall coordination the State Governments, Implementation Societies and to arrange technical/professional support for programme.

» NCERT and NIEPA are autonomous bodies, which serve as national apex institutions and their services are utilised for academic and technical support for

the programme implementation as and when required. DPEP Bureau is part of the Central Government's structure.

There is no system of maintaining and retaining the applications received in response to advertisements issued by the Ministry for a period beyond one year. Selections are made by duly constituted Selection Committees on the basis of merit, and not on the basis of region. Hence no region-wise records are maintained.

Guidelines for releasing grants/aids for playground / stadium

- 1127. SHRI BANGARU LAXMAN: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:
- (a) what are the guidelines adopted by Government of India for releasing grants/aids for playground / stadium etc. in the different States of the country;

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SUSHREE BHARATI): (a) There are no guidelines for State-wise release of grant construction of playground/stadium. Grants are released to the States on the basis of proposals received from them. Under the guidelines, the cost of the project is shared between the Union Government and the State Government/ Sponsoring agencies in the ratio of 75:25 in respect of the hilly/tribal areas and 50:50 in case of other areas. However, the Central assistance is limited to certain ceilings as specified in the guidelines.

- Statement showing State-wise details of grants released during the last three years is given (see below).
- (c) As per scheme, grants are released to the State Government/Sponsoring agencies only on the basis of proposals submitted by them. In case proposalsare received, the Central Government will not be in a position to sanction any grant. Only if the concerned State Government initiates steps towards forwarding proposals to the Central» Government seeking Central assistance for creation of sports infrastructure under the prevailing guidelines, can such proposals be considered.
