#### New Technology for Purifying Waste Water

1062. SHRI SATISH PRADHAN: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:

- (a) whether it is a fact that Houseman Ltd. U.K. and an Indian Company, M/s. Aquafarm Chemicals Ltd., Pune, have developed a new technology of purifying the waste water; and
- (b) if so, whether Government will make the use of this technology mandatory for habitual water polluting industries which has affected the use of potable water especially in rural India?

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI BUBULAL MARANDI): (a) and (b) No information about the new technology of purifying the waste water has been made available by the company to the Maharashtra Pollution Control Board and the Ministry of environment & forests. As a matter of policy, the Ministry of environment & Forests normally does not prescribe any proprietry technology of a particular company. Industries are required to conform to the prescribed environmental standards by adopting suitable treatment technology.

पर्यावरण और वन मंत्रालय में राज्य मंत्री (श्री बाबूलाल मरांडी): (क) और (ख) उत्तर प्रदेश सरकार से प्राप्त सूचना के अनुसार, फिछले एक वर्ष के दौरान कार्वेट राष्ट्रीय अध्यारण्य के बाहर दो बाघों को जहर देकर मारने की घटनाएं सूचित की गई हैं। तथापि, इन घटनाओं में अध्यारण्य के किसी भी अधिकारी की मिलीभगत देखने में नहीं आई है।

- (ग) जी, हां, विश्व बाजार में बाघ के शारीर के अंगों की भारी मांग के बारे में कुछ सूचनाएं प्राप्त हुई हैं।

## Legislation to Protect Bio-Diversity

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI BABULAL MARANDI): (a) to (d) Following broad based consultations on the subject matter after India became a Party to the Convention on Biological diversity in 1994, the Government constituted an Expert Committee in August, 1997 to suggest a draft legislation on Biological Diversity.

The committee gave a draft outline of an Act on Biological diversity in October 1997. In pursuance thereof, this matter is under further examination.

#### Effects of Nuclear Weapons Explosions on Environment

- (a) what can be the effects of nuclear weapons utilisation and its explosions;

- (e) what precautions were taken to avoid or diminish its ill-effects?

stock-pole of hazardous waste in the 1000 odd Inland container Depots all over the country, has detected enormous stock-piles of battery scrap, leadish waste oil and zinc-ash and other hazardous waste in these Depots;

- (b) if so, the details of the hazardous waste piled up at these Depots and how so much of this waste found its way into the country despite the Basel-Convention adopted in 1995; and
- (c) what is Government's reaction thereto?

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI BABULAL. MARANADI): (a) and (b) The High Powered Committee appointed by the Supreme Court has been asked to look into the quantum and nature of hazardous wastes lying at various ports and container depots throughout the country. As per the information supplied by various ports and inland container depots, the status of hazardous wastes lying at some of the ports and container depots is given in the annexure. [See Appendix 184, Annexure No. 36]. The import of hazardous waste into the country is governed by Hazardous Waste (Mangement and Handling) Rules, 1989 and in accordance with the provisions of Basel Convention. The hazardous wastes lying at ports and container depots are the unclaimed consignments which were taken in custody by the Customs Authorities in view of Delhi High Court Order banning the import of hazardous wastes.

(c) Samples of hazardous wastes lying at various ports and container depots have been collected and their analysis is in progress.
