Environmental wing for pollution control

- *147. SHRI DEBABRATA BISWAS: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:
- (a) whether there is a proposal to open an Environmental Wing in his Ministry to monitor various pollution control measures at the Central level;
- (b) if so, the details thereof and if not, the reasons therefor; and
- (c) what further steps are proposed to be taken to control effectively the environmental pollution which has of late assumed serious proportions?

OF THE MINISTER **ENVIRONMENT** AND **FORESTS** (SHRI SURESH PRABHU): (a) and (b) Under the Water (Prevention & Control of Pollution) Act, 1974 and the Air (Prevention & Control of Pollution) Act, 1981, the responsibility of monitoring is primarily entrusted to the State Pollution Control Boards. In addition, the existing Pollution Control Division in the Ministry already monitoring environmental pollution through the Central Pollution Control Board (CPCB), using a network of ambient air (290) and water quality (480) monitoring stations established throughout the country. CPCB also conducts surveys in the major Indian cities to assess the levels of noise and vehicular pollution.

- (c) Steps taken to control environmental pollution in the country includes the following:
 - (i) Emission and effluent standards have been notified for the major categories of polluting industries.
 - (ii) Industries have been directed to install necessary pollution control system to conform to the prescribed environmental standards within a stipulated time-frame and legal action is taken against the defaulting units.
 - (iii) Environmental Impact Assessment has been made mandatory from 27.1.94 for 29 specified categories of development projects. Stringent conditions are imposed while granting environmental clearance to the projects.
 - (iv) A scheme under the World Bank has been initiated for setting up of Common Effluent Treatment Plants (CETPs) in cluster of small scale industrial units. In this scheme, 50 percent of the subsidy is given by the Government, 30 percent soft loans are made available by the Industrial Development Bank of India (IDBI) and only 20 percent of the investment is from the beneficiaries. So far 77 CETPs have been sanctioned and are at various stages of implementation.
 - (v) A scheme for promotion, development and adoption of clean technology including utilisation of

(c) The line at item (1) above, would be about 300 km long and will cost about Rs. 650 crs. However, a traffic survey has been taken up so that further consideration of the project becomes possible.
