## Assessment of Law and Order in States by **Central Teams**

- 2358. SHRI SANATAN BISI: Will the Minister of HOME AFFAIRS be pleased to
- (a) whether sending of central teams to assess the law and aorder situation in the States in within the ambit of article 355 of the Constitution; and
  - (b) if so, the details thereof?

THE MINISTER OF HOME AFFAIRS (SHRI L. K. ADVANI): (a) and (b) Yes, Sir. Article 355 of the Constitution of India casts a duty on the Union to protect every State not only against external aggression but also internal disturbance and to ensure that the Government of every State is carried on in accordance with the provisions of the Constitution. In the discharge of this duty, the Central Government is expected to keep itself posted with respect to goings-on in all States. Visits of Central officials to the States are part of this process. The Central and state Governments have all along been interacting on issues relating to law and order.

# Reang Families in Tripura Refugee Camps

- 235Q. SHRI KHAGEN DAS: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether a large number of families belonging to Reang community have taken shelter in the refugee camps in Tripura after leaving their villages in Mizoram;
  - (b) if so, the details thereof;

- (c) whether Government will meet the expenditure on account of providing necessary amenities to these refugees; and
- (d) what steps have been taken to ensure early return of these families to their villages in Mizoram?

# THE MINISTER OF HOME AFFAIRS (SHRI L. K. ADVANI): (a) Yes, Sir.

- The exodus of Reang from Mizoram started in October/November 1997 in the wake of ethnic tension between Mizos and Reangs in Tuipuibari area of Aizawl West District. The exodus towards Tripura and Assam continued till February/March 1998 on the major chunk of Reang refugees taking shelter in Gochirampara refugee camp (Tripura). The number of such refugees has crossed 30,000.
- Government (c) The Central providing financial assistance to Governments of Tripura and Assam towards maintenance of these refugees.
- (d) The Central Government is keen on ensuring early return of refugees to their villages in Mizoram. This has been upon all impressed the concerned agencies. Government of Mizoram hasassured the refugees of proper security, speedly development of their area in Mizoram and financial assistance for their rehabilitation. An inquiry into allegations of excesses committed upon them has also been offered.

#### Reimbursement of **Security-Related Expenditure to States**

- 2360. SHRI KHAGEN DAS: Will the Minister of HOME AFFAIRS be pleased to
- (a) whether Government have reimbursed security-related expenditure to the States of Punjab, Jammu and Kashmir and Assam:
- (b) whether it is a fact that request of some other States. including Tripura, reimbursement of security-related expenditure are pending with Government:

- (c) if so, whether Government will reimburse security-related expenditure to this State as it has done in the case of Jammu and Kashmir, Punjab and Assam;
- (d) by when, the reimbursement will be made to the State Governments?

THE MINISTER OF HOME AFFAIRS (SHRI L. K. ADVANI): (a) Yes, Sir, the Centrla Government has reimbursed security-related expenditure to the State of Jammu and Kashmir and to Assam for the period 1990-95. As far as Punjab is concerned, the instalments of principal and interest for the years 1997—2000 pertaining to the Special Term Loans given to Punjab during the years from 1984-85 to 1993-94 have been waived by the Centre.

- (b) Yes, Sir.
- (c) and (d) The Central Government are in the process of formulating and finalising the eligibility criteria and the guidelines for reimbursement of security-related expenditure in respect of North Eastern States. Reimbursement would be possible after approval of the guidelines and adequate provision of funds in this regard.
