2365. DR. ALLAKI P. RAJKUMAR: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether a comprehensive review has been made of internal security problems being faced by some of the Southern and Central Indian States; and
- (b) if so, teh details of plans drawn up tp help those States fight the naxalite and other related problems?

THE MINISTER OF HOME AFFAIRS (SHRI L.K. ADVANI): (a) Yes, Sir.

- (b) Central Government, in consultation with the concerned States has drawn an Action Plan to fight the naxalite and related problems, which includes:
 - (i) Ensuring security of police stations, particularly those located in nexalite affected areas;
 - (ii) to have a common communication system;
 - (iii) set up a Control Room in each State;
 - (iv) Joint patrolling;
 - (v) launching of Area Domination Programme among the States;
 - (vi) Strenthening of intelligence network in affected areas in the affected States;
 - (vii) ensuring of training of police personnel in anti-externist operations.

In addition, the State Governments have also been advised to piese Concentrated attention on the implementation of development Plans.
