Will the Minister of LAW AND JUSTICE be pleased to state:

(a) whether a proposal to set-up a National Judicial Commission as per Supreme Court verdict in 1993 is under consideration of Government;

(b) if so, the details thereof;

(c) whether it is also a fact that Government is considering setting-up of a five member Judicial Commission as suggested by legal experts including Supreme Court and High Courts Judges for appointment, transfer, etc. from the High Courts/Supreme Court; and

(d) if so, whether Government is contemplating to amend certain related articles of the Constitution of India?

THE MINISTER OF LAW, JUSTICE AND COMPANY AFFAIRS AND THE MINISTER OF SURFACE TRANSPORT (SHRI M. THAMBI DURAI): (a) to (d) One of the items of the National Agenda for Governance is to set up a National Judicial Commission to make recommendations for judicial appointments in the Supreme Court and the High Courts and draw up a code of ethics for the judiciary. It is not possible to indicate the time by which the final decision in this regard would be taken.

**Vacancies of Judges in Allahabad High Court**

1483. SHRI NAGMANI: Will the Minister of LAW AND JUSTICE be pleased to state:

(a) whether Government are aware of the fact that in Allahabad High Court the approved strength of judges is 77 and out of them there are at present 29 vacancies resulting into failure of justice delivery system in the state; if so, the reasons therefor;

(b) whether Government propose to amend Law that vacancies of judges be filled three months prior to the date of retirement of judges; and

(c) whether any step has been taken to fill-up vacancies of judges in Allahabad High Court?

THE MINISTER OF LAW, JUSTICE AND COMPANY AFFAIRS AND THE MINISTER OF SURFACE TRANSPORT (SHRI M. THAMBI DURAI): (a) The approved strength of the Allahabad High Court is 77 Judges/Additional Judges. As on 1.6.1998, 48 Judges were in position, leaving 29 vacancies of Judges/Additional to be filled up.

(b) No, Sir.

(c) The procedure for appointment of judges of High Courts involves consultation among several constitutional authorities. Every effort is being made to fill existing vacancies at the earliest.
