THE MINISTER OF **CIVIL** (SHRI AVIATION ANANTH KUMAR): (a) Due to shortage of apron space for aircraft parking and two-level operation of passenger terminal building, aerobridges have to be provided.

- (b) The total cost of four aerobridges to be installed at Hyderabad airport is Rs. 685 lakhs.
- and (d) Even though two aerobridges on international side were installed in October, 1997, there were delay in commisioning due to the replacement of some parts that got damaged during transportation and servicing of the equipment through the Finally, supplier. these were commissioned on 31.5.1998. Two aerobridges on the domestic side are likely to be commissioned in October, 1998, after the work of modification of existing domestic terminal is completed.
