(a) whether Government have fixed any target for laying of telephone lines for providing telephone connections in the Vidarbha region of Maharashtra during the current financial year;

(b) if so, the details thereof;

(c) whether necessary funds have been earmarked for this purpose; and

(d) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI KABINDRA PURKAYASTHA):  
(a) Yes, Sir.

(b) The details of tentative targets for net capacity addition for 98-99 for various telecom districts of Vidarbha region are as under:—

Akola	5,000 Lines
Amravati	9,000 Lines
Bhandara	7,000 Lines
Buldhana	4,000 Lines
Chandrapur & Gadchiroli	11,800 Lines
Nagpur	22,000 Lines
Wardha	3,500 Lines
Yavatmal	5,000 Lines

(d) Approximate Rs. 197.80 crores have been proposed for development in the Vidarbha region.

#### Subscribers Protest against DOT's Irregularities

1388. SHRI SATISH PRADHAN: Will the Minister of COMMUNICATIONS be pleased to state:

(a) whether it is a fact that subscribers in Vasai (Maharashtra) have observed bandh in protest against irregularities of DOT.

(b) whether it is a fact that DOT employees have been accused of high handedness and corruption;

(c) whether it is fact that high official of DOT have admitted that entire disruption is due to the inefficient working of DOT employees;

(d) whether it is also a fact that honourable Minister of State for Railways have written letters to General Manager DOT, Kalyan, which have been ignored; and

(e) what action Government propose to take against the incompetent and arrogant employees in Vasai?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI KABINDRA PURKAYASTHA):  
(a) Yes, Sir.

(b) Nothing has been reported in writing.

(c) The entire disruption of service has taken place on few occasions due to failure of OCB exchange on account of technical problems and frequent interruptions due to cutting of optical fibre cable (OFC) on National Highway in many locations from Vasai to Charoti, due to road widening works which are in progress. The entire Telecom including S.T.D./The service of Vasai, Palghat, Dahanu and Talasari were frequently disturbed completely on account of OFC interruptions since the connectivity of all these exchanges is only through this O.F.C. with the Mumbai Trunk Automatic exchanges.

(d) No, Sir. Letter received from Hon'ble Minister of State for Railways have been replied and attended promptly.

(c) Instructions have been issued to the employees/officers to be polite to the customers and provide the New Telephone Connections within a month and clear the pending faults in a week's time. A further watch on their performance is being kept.

**रियायती दर पर टेलीफोन सेवाएं उपलब्ध कराने के लिए "ग्रामीण पैकेज"**

(क) क्या यह सच है कि ग्रामीण क्षेत्रों में रियायती दर पर टेलीफोन सेवाएं उपलब्ध कराने के लिए प्रारम्भ किये गये "ग्रामीण पैकेज" की सरकारी घोषणा तथा इस संबंध में सरकार द्वारा आदेश जारी करने के बावजूद इसे अभी तक कार्यान्वित नहीं किया जा सका; और

(ख) यदि हां, तो इसके क्या कारण हैं और सरकार इस पैकेज को कब तक पूरी तरह कार्यान्वित कर देगी?

संचार मंत्रालय में राज्य मंत्री (श्री कबीर प्रकाशस्थ) (क) और (ख) जी, नहीं। 22.11.95 को घोषित किए गए ग्रामीण दूरसंचार पैकेज में ग्रामीण उपभोक्ताओं की रियायती टैरिफ, मुफ्त कॉलों की संख्या में वृद्धि, कम पंजीकरण शुल्क और किराए इत्यादि की परिकल्पना की गई है।

ग्रामीण दूरसंचार पैकेज में परिकल्पित विभिन्न विशेषताओं की विभिन्न सर्किटों तथा मैट्रो जिलों के सभी स्थानों में कार्यान्वित कर दिया गया है।

#### Telecom factories under D.O.T.

1390. SHRI NILOTPAL BASU: Will the Minister of COMMUNICATIONS be pleased to state:

(a) whether it is a fact that the Telecom factories under DOT have large assets in different parts of the country;

(b) if so, the details thereof togetherwith the number of employees and their present level of utilisation;

(c) whether it is also a fact that the level of utilisation is adversely affected by obsolescence of technology; and

(d) if so, the measures to be undertaken by Government for asset evaluation, modernisation, retraining of

employees etc. and the details thereof towards a more productive use of these assets?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI KABINDRA PURKAYASTHA):

(a) Yes Sir,

(b) The details are given in the Statement. (See below)

(c) The bulk of the equipment made are line materials such as Poles, Brackets, U-Backs etc, which are utilised in the 'last mile' of the telephone network. Due to enormous expansion of Public Switched Telephone Network, there is adequate demand for these materials for giving new connections. The factories are meeting the bulk of the requirement of the DOT in regard to line materials. Their capacities are being fully utilised. Efforts are also being made to diversify into new areas which are detailed in the following para.

(d) In order to diversify and modernise the Telecom factories, several new products viz. CT Box, DP Box, MDFs for C-DOT exchanges, Modems, 15M & 40M self supporting masts, 60/80 M Hybrid Tubular Towers, Support Brackets, CBT-95. Pay Phones etc. have been identified for manufacture replacing some of the obsolete products.

The employees have also been trained and redeployed on new products. Efforts are continuously made to gainfully utilise the surplus staff. It is proposed to introduce some more products to fully engage the manpower and for more productive use of the assets.
