(c) As on 1-4-1998, the distributorship has 3930 number of customers and all of them have been issued the Subscription Vouchers.

Survey to determine backwardness in Tripura

2563: SHRI KHAGEN DAS: Will the PRIME MINISTER be pleased to state:

- (a) whether Government propose fresh survey in Tripura to determine the level of backwardness in the State: and
- (b) if so, what steps have been taken by Government?

Tripura is, however, one of the States covered under all-India surveys conducted by National Sample Survey Organisation (NSSO) in their various rounds, the last such surveys (54th round - January to June, 1998) was on Use of Common Property Resources, Sanitation and Hygiene & Services' and on 'Consumer expenditure and Employment & Unemployment'.

Increase in the allocations for MPLAD Fund

2564. SHRI SANJAY NIRUPAM: Will the PRIME MINISTER be pleased to state:

- (a) whether Government propose to double the amount of MPLAD Fund i.e making it to Rs. 2 crores;
- (b) if so, by when an announcement is expected; and

The request is under consideration. However, no decision has been taken by the Govt. in this regard so far. The funds are released to the MPs with reference to the actual progress achieved in expenditure and execution of works. Hence the question of payment of interest to the delayed releases does not arise.

Enhancement of Sub-hiil plan budgetary provision of Assam

SCA under HADP is distributed amongst the Designated Hill Areas on the basis of area and population giving equal weightage to each these variables. The Union Budget for 1998-99 has proposed an enhanced allocation of Rs. 390 crore for Hill Areas Development Programme against Rs. 352

crore allocated last year i.e. 1997-98. Hence the provision for designated Hill areas of Assam is also expected to increase.

Funds allotted for social sector 2566. DR. B.B. DUTTA: Will the PRIME MINISTER be pleased to state:

- (a) whether the social sectors are starved of funds:
- (b) if so, the funds requirement of the social sectors and allotments made during the Sixth, Seventh, Eighth and Ninth Plans, sector-wise; and

There has been a steady increase in the funds allocated to social Services in the Plan outlay, 14.4% in the Sixth Plan, 17.5% in the Seventh Plan and 18.2% in the Eighth Plan. The details of the allocations made for various social services during Sixth, Seventh and Eighth Plan are given in the following table:
