held discussions with the Prime Minister. The talks covered bilateral relations, regional and international matters.

115 Written Answers

Both sides agreed on the need to intensify the excellent relations that exist between the two neighbouring countries, to increase exchanges at various levels including Parliamentary delegations, students and cultural groups and to step up commercial and economic interaction. Border and securityrelated issues were reviewed. Both sides reiterated their commitment to SAARC in view of the important role it could play in promoting regional cooperation.

## Rationale of Negotiating Kashmir issue with Pakistan

- (b) if so, what is the rationale of negotiating Kashmir issue with Pakistan, as announced recently by the Prime Minister?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRIMATI VASUNDHARA RAJE): (a) and (b) The State of Jammu & Kashmir is an integral part of the Indian Union. A part of the territory of the State is under the illegal and forcible occupation of Pakistan. India is committed to resolution of all outstanding issues with Pakistan, including its continuing occupation of a part of the territories of the State of J&K, through peaceful means and bilateral discussions.

## **Border Trade with Bangladesh**

2507. SHRI KHAGEN DAS: Will the PRIME MINISTER be pleased to state:

(a)'whether there is any proposal sent by North-Eastern States for facilitating border trade with Bangladesh;

- (b) if so, what steps have been taken by Government in this regard; and
