notes, is primarily the responsibility of the State Governments.

However. in order to combat counterfeiting, currency notes are now printed on a specially made cylinder mould vat made paper with additional security features._ The Reserve Bank of India issues Press releases, from time to time, to enable the public to distinguish between genuine and fake currency notes. The Border Security Force has alerted its forward troops to be more vigilant.

Blasts in Coimbatore

1583. DR. D. VENKATESHWAR RAO: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether Government of Tamil Nadu has confirmed that the target of blasts in Coimbatore during the General Election meeting on 14th February, 1998 was the B.J.P. leader, Shri L.K. Advani; if so, the details thereof: and
- (b) the action taken to ban the extremist organisations associated with the blasts?

THE MINISTER OF HOME AFFAIRS (SHRI L.K. ADVANI): (a) As per information furnished by the State Government of Tamil Nadu, the Special Investigation Team of the Crime Branch CID constituted by the State Government to investigate the bomb blasts which took place in Coimbatore on 14.2.98 were planned by Al-Umma to cause heavy loss to human lives and properties to avenge the loss suffered by Muslims during the communal violence in November, 1997. It has also been reported that seven activists had been prepared to target Shri L.K. Advani. However, according to the State Government these activists could not gain access to the venue due to elaborate security measures.

(b) The state Governijent has already two banned Muslim Fundamentalist organisations, viz., the Al-Umma and All India Jihad Committee suspected to be involved.

Downgrading the security of VVIPs
