- (v) North Eastern States have been designated as the theme States for Suraj Kund Craft Mela, 1998.
- (vi) North Eastern States have been given special focus in the Marketing Conference of overseas offices of the Department held during the first week of June 1997 in Delhi. All our overseas offices have been giving publicity on North East.
- (vii) North Eastern States are included in the Home page of Department of Tourism in INTRNET.
- (viii) A new travel circuit Guwahati-Kaziranga Shillong-Tawang has been announced.
- (b) There is no system of providing incentives by the Government to tourists to visit any place in the country.
