The financial assistance released to the Government of Assam for implementation of tourism projects during the last three years was as given below:

The Government develops infrastructure facilities in these pilgrim centres with the combined efforts of Central and State govts., religious institutions and private sector.

 - 1. Tirupati (Andhra Pradesh)
 - 2. Kamakhya (Assam)
 - 3. Bodh Gaya and Patna Saheb (Bihar)
 - 4. Dwaraka, Palitana and Udwad (near Vapi Gujarat)
 - 5. Paonta Saheb and Jwalaji (Himachal Pradesh)
 - 6. Mata Vaishno Devi (Jammu & Kashmir)
 - 7. Sringeri and Gulbarga (Karnataka)
