THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI SOMPAL): (a) to (d) The total funds allocated during the Eighth Five Year Plan for irrigation sector in the country was Rs. 30,395.63 crores. The State-wise and yearwise details of funds

allocated for irrigation projects alongwith the State-wise details of number of Major, Medium and Extension, Renovation & Modernisation (ERM) projects completed during the Eighth Five Year Plan are enclosed at Statement. (See below) As regards the Minor irrigation schemes, the details of completed projects are not maintained at Union Government level. The reasons for slow progress in completion of irrigation pro-jects include (i) financial constraints, (ii) proliferation of projects resulting in thin spreading of resources and consequent time and cost over-runs, (iii) change in scope and design of projects during construction, etc. In addition to advising the State Governments to provide higher plan allocations for irrigation sector. the Union Ministry of Water Resources has also launched "Accelerated Irrigation Benefits Programme" (AIBP) since 1996-97 to expedite completion of selected ongoing projects which are at the advanced stage of construction and can yield benefits within a short timeframe. Central Loan Assistance of Rs. 500.00 crores and Rs. 952.19 crores has been released to the States under AIBP during 1996-97 and 1997-98 respectively.
