### **Inadequate infrastructure In Coal Sector**

- (a) whether it is a fact that the Infrastructure to handle the growing demand and production of coal is inadequate; and
- (b) how does Government plan to overcome this shortage?

THE MINISTER OF STATE OF THE MINISTRY. OF COAL (SHRI DILIP RAY): (a) Yes, Sir. There has been mismatch between production and transport capacities in some of the coal producing areas.

(b) Ministry of Coal and Coal Companies are taking steps to improve despatches by rail in coordination with the Railways for increased evacuation of coal from coalfields of Talcher, lb Valley, North Karanpura and Korla, Steps are also constantly made to improve the infrastructure for evacuation of coal produced by the coal companies by Rail cum-sea movement by revamping port infrastructure.

#### French collaboration in Khottadih Colliery

2759. SHRI GURUDAS DAS GUPTA: Will the Minister of COAL be pleased to state:

- (a) whether underground of Khottadih colliery under Eastern Coalfields Ltd. envisaging deployment of Powered Support Equipment and Project was implemented in collaboration with France;
- (b) whether, after starting production in July, 1994 the powered support

equipment got damaged in April, 1997;

- (c) if so, what is the reason for the damage;
  - (d) what was the cost of the project; and
- (e) what is the total loss of coal production and amount caused thereby?

- (c) The powered support longwall face equipment was damaged due to massive dynamic loading of the overlying strata.
- (d) The cost of the project was Rs. 340.86 crores, of which the dost of the longwall equipment was Rs. 92 crores.
- (e) It has been reported by Coal India Limited that due to damage to the equipment the annual loss of production is 0.S8 million tonnes of a value of Rs. 58 crores
