## Merger of BICP with Tariff Commission

The marger of the Bureau of Industrial Costs and Prices (BICP) with the Tariff Commission is being proposed in order to draw upon the expertise developed by the BICP over the years in the areas of technology, economic analysis, finance and cost accountancy in furtherance of the emerging requirements.

- 2. The nominee of SMC will be appointed as Chairman of MUL.
- 3. In future, all appointments of Chairman and Managing Director either by GOI or SMC will be only in consultation and with the concurrence of the other party.
