THE MINISTER OF STATE IN THE MINISTRY OF RAILWAY, OF STATE IN MINISTER MINISTRY OF PARLIAMENTARY AFFAIRS, AND THE MINISTER OF STATE IN THE MINISTRY OF PLANNING AND **PROGRAMME** IMPLEMENTATION (SHRI RAM NAIK): (a) As per the information received from Distt. Collectors till 31.5.1998, an amount of Rs. 471.69 lakhs have been spent since the inception of the scheme on various works in respect of Rajya Sabha Members. Year-wise details of utilization of funds are not being maintained separately as the funds released under the Scheme are non-lapsable and the amount lying unutilised in a particular year can be carried forward to the next financial year.

- (b) The works taken up under the Scheme include construction of school buildings, libraries, roads, bridges, community centres, public toilets and drilling of tubewells. Computers to Government and Government aided's schools have also been provided under MPLADS.
- (c) Members of Parliament are required to recommend works within the frame-work of guidelines on MPLAD Scheme.
