Percentage of women in All-India Services

(a) whether there is any proposal to fix 33 percent quota for women in All-India Services;

(b) what is the present percentage of women in the IAS and IPS; and

(c) what steps are proposed to be taken to increase the percentage of women in All-India Services?

THE MINISTER OF STATE IN THE MINISTRY OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS AND THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (BANKING, REVENUE AND INSURANCE) (SHRI R. JANARTHANAM): (a) No, Sir.

(b) The present percentage of women in IAS is 10.68 and in IPS is 3.11.

(c) Recruitment policies do not discriminate against women. There is a constant endeavour to ensure that service conditions are not against the interests of women.

Pakistan's Plan of Nuclear Strike

(a) whether Government's attention has been drawn to the news-item which

appeared in the Hindustan Times, dated 29th June, 1998 quoting a Pakistani defected weapons scientist disclosing Pakistan's plan of first Nuclear strike on the country; and

(b) if so, what is Government's reaction with regard thereto?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRIMATI VASUNDHARA RAJE):

(a) and (b) Yes, Sir. Government has taken note of this report. Government remains fully committed to taking all necessary steps to effectively safeguard India's security and national interests in accordance with its own threat perceptions.
