Loss of Revenue to Railways due to defects in tttc Computerised Ticket Booking System

(b) how many crores of rujjces of revenue Railways have lost because of defects in the computer tickets booking system Installed by keltron, during the last three years;

(e) whether Keltron is held responsible partly or fully for the defects in the system?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI RAM NAIK): (a) to (c) On getting information that there was some discrepancy in the issue of general tickets through Self Printing Ticket Machines (SPTMs) supplied by M/s. Keltron at Secunderabad station, a joint team of Commercial, Accounts and Vigilance Officers/Inspectors was formed to seize all the records and suspend the working these Though of machines. the suspected manipulation was at Secunderabad station, the machines available at Kachcguda and Hyderabad were also suspended for operation and' records seized as the SPTMs of above three stations were supplied by M/s. Keltron Ltd. Preliminary investigations revealed that two booking clerks at Secunderabad station have misappropriated an amount of Rs. 1661/-. They have been suspended and taken up under Discipline & Appeal Rules.

(d) Preliminary investigations have not established the involvement of M/s. Keltron Ltd.
