## Payment of Salary to the Staff of Nagpur Nutritional Monitoring Bureau

3425. SHRI VIJAYA Α. RAGHAVAN: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether representations have been made by the Nagpur Nutritional Monitoring Bureau staff that they have not received salary for months of April-May, 1998 and that National Institute of Nutrition, Hyderabad which is to send D/ D for the purpose has not yet sent the D/D:
- (b) whether non-payment of salary regularly every month has become a regular feature;
- (c) the reasons for non-payment of salary regularly; and
- (d) by when, the payment for April and May, 1998 is likely to be made?

THE MINISTER OF STATE OF THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI DALIT EZHILMALAI): (a) Yes, Sir.

- (b) No Sir.
- (c) and (d) The Nagpur Nutritional Monitoring Bureau is a temporary project funded by the Indian Council of Medical Research. Normally, the Council releases funds to the Bureau in three instalments. The first instalment for 1998-99 was released on 15.5.98 and the payments for April and May 1998 for salaries etc. have already been released.

Prevalence of Asthma Among Children

3426. SHRI PREM CHAND GUPTA: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to

- (a) whether it is a fact that the study conducted by the cardio-respiratory department of Patel Chest Institute showed that 2.5 lakh children are suffering from asthma and the prevalance of the disease is 16-17 per cent:
- (b) if so, action taken by Government in this regard;
- (c) whether the rate of respiratory diseases in Delhi is 12 times more than the national average;
- (d) if so, the reasons therefor, and steps taken by Government in this regard: and
- (e) if not, the reasons for the slackness?

THE MINISTER OF STATE OF THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI DALIT EZHILMALAI): (a) and (b) In a sample survey conducted by the Vallabhbhai Patel Chest Institute in nine randomly selected Delhi schools it was inter-alia found that the prevalence of asthma was 12%. The Indian Council of Medical Research has reported that there is no direct evidence to suggest that air pollution by itself can be the cause of asthma. Allergens like pollen, house-dust and certain food articles can however, trigger off asthma attacks.

- (c) Data relating to morbidity from asthma is not collected by any States in the country or by the Registrar General of India. Asthma is not a notifiable disease.
- (d) and (e) Apart from providing health education and treatment facilities for the disease, the Government have launched several measures to control pollution including measures to limit exhaust stroke from vehicles.
