general, perception about the economic policy of the goveramcBt and the developments of the international capital market. The principal ensideration of the government and SEBI is to ensure orderly and transparent functioning of the market. The government and SEBI take ioto account all suggestions received from various sources including industry while formulating policies.

## Reasont for lossea in CPSUs

3568. SHRI MARENDERA MOHAN: Will the MWiter of INDUSTRY be pleased to state:

- (a) whether it it a fact that annual losses of Central Public Sector Undertakings for 1996-97 were Rs. 5,862
- (b) if so, what are the reasoAs therefor and the steps Governmeift have taken during the last three years to make these PSUs viable; and
- (c) whether this downward slide is attributable to policy or enefSnent management?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI SUKHBIR SINGH BADAL): (a) The net profit earned by CPSUs during 1996-97 was of the order or Rs. 10258 crores after adjusting the losses of Rs. 5862 crores incurred by loss making CPSUs.

(b) and (c) The reasons for lost making are enterprise specific and include obsolete plant & machinery, outdated technology, adverse market conditions, excess manpower, working capital shortage, heavy interest burden, social obligations, etc.

Aport from the enterprise specific measures, the steps taken by the Government include prcrfessionalisation of Boards, periodic performance review meetings by the administrative Ministries,

entering into Memorandum of Understanding with the undertakings, ratioaalisatiop  $\alpha f$ 

manpower-

organisational and capital nstructuring including formation of joint ventures, lechndogy upgration, etc.

## Revival of the HMT and **Instrumentation Limited**

3569. SHRI VAYALAR RAVI: Will the Minister of INDUSTRY be pleased to state:

- (a) whether Government have made any proposal to revive HMT and Instrumentation Limited; and
- (b) if so, what are the proposals and steps taken so far to improve the performances of these industries?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI SUKHBIR SINGH BADAL): (a) and (b) HMT is working on a revival plan for the company. Revival of Instrumentation Ltd. is before BIFR which is a quasijudicial body. The performance of HMT and Instrumentation Ltd. are regulariy monitored and reviewed by Government.
