THE MINISTER OF STATE IN THE VIINISTRY OF FINANCE (SHRI R. 1ANARTHANAN): (a) and (b) Section 2d of the Sick Industrial Companies ;Spceia! Provisions) Act, 1985 (SICA) Jeals with winding up of sick industrial companies. The said section also provides hat the Board for industrial and Financial Reconstruction (BIFR) may cause to be sold the assets of the sick ndustrial companies in such manner as it may deem fit and forward the sale iroceeds to the High Court for orders for distribution in accordance with the jrovisions of section 529A, and other irovisions of the Companies Act, 1956. IFR. has reported that as on 30.6.1998, our of 594 sick industrial companies ecommended by it to respective High Coans for winding up, it ordered sale of assets of 48 companies.

## **Shortage of Currency Notes/Coins**

- (b) the steps proposed to print enough notes in the country to meet the shortage and replace the soiled/tattcrcd notes; and

THE MINISTER OF FINANCE (SHRI YASHWANT SINHA): (a) The existing Note Printing Presses are able to meet only about 35% of RBI's demand for fresh notes. Similarly, the existing four Government of India Mints together
