MINISTER THE CIVII. AVIATION ANANTH (SHRI KUMAR): (a) to (e) Airports Authority of India has provided Rs. 4 crorcs in the Annual Plan 1997-98 for this purpose. There exists a provision of Rs. 20 crores in the Annual Plan for 1998-99. Airports Authority of India has floated tenders for exctension of. runway from 9,000 ft. to 11,500 ft. and strengthening of associated payments at a cost of Rs. 48.50 crores for operation of B-747~type of aircraft. This work is likely to be completed in two years from the date of its award. AAI is also planning upgradation of the terminal building.

The post of Whole-time Chairman in the Airports Authority of India (AAI) became vacant on 14.10.19% and the Joint Secretary in the Ministry of Civil Aviation had been holding additional charge of the post till the appointment of the new Chairman. On the basis of the recommendations of the Public Enterprises Selection Board and with the approval of the competent authority Shri D.V. Gupta has been appointed as Chairman, AAI with effect from 6.7.1998.
