Upgradation of Sardar Vallabhbhai Patel International Airport

3677. SHRI BANGARU LAXMAN: Will the Minister of CIVIL AVIATION be pleased to state:

- (a) whether the proposal for upgradation of the Ahmedabad Airport named as Sardar Vallabhbhai Patel International Airport is pending with Government;
- (b) whether the State Government of Gujarat and its people are very much concerned in this regard and the State Government has many times in the past approached the Central Government in the matter;
- (c) if so, the details thereof and facts thereon:
- (d) whether Government are not concerned to give recognition to the great freedom fighter and builder of the nation in the Golden Jubilee Celebration year of the Independence; and
 - (c) if so, the reasons for delay?

THE MINISTER OF CIVIL AVIATION (SHRI ANANTH KUMAR); (a) to (e) Airports Authority of India has provided Rs. 4 crores in the Annual Plan 1997-98 for this purpose. There exists a provision of Rs. 20 crores in the Annual Plan for 1998-99. Airports Authority of India has floated tenders for excussion of runway from 9,000 ft. to 11,500 ft. and strengthening of associated payments at a cost of Rs. 48.50 crores for operation of B-747 type of aircraft. This work is likely to be completed in two years from the date of its award. AAI is also planning upgradation of the terminal building.

Appointment of Chairman for AAI

(a) whether it is a fact that the Airports Authority of India (AAI) is

without a Chairman for the last two or three years; and :

(b) if so, the reasons therefor and by when this position is likely to be filled?

OF CIVIL MINISTER THE AVIATION (SHRI ANANTH KUMAR): (a) and (b) No, Sir. The post of Whole-time Chairman in the Airports Authority of India (AAI) became vacant on 14,10,1996 and the Joint Secretary in the Ministry of Civil Aviation had been holding additional charge of the post till the appointment of the new Chairman. On the basis of the recommendations of the Public Enterprises Selection Board and with the approval of the competent authority Shri D.V. Gupta has been appointed as Chairman, AAI with effect from 6.7.1998.
