Financial Support to Prasar Bharati

3794. SHRI KARNENDU BHATTACHARJEE: Will the Minister AND INFORMATION BROADCASTING be pleased to state:

- (a) whether Government will continue its financial support to the 'Prasar Bharati' without monitoring performance in the greater national interest:
 - (b) if so, the details thereof;
- (c) whether Government have set any deadline for framing its own rules, regulations and staff policy by the Prasar Bharati Board; and
- (d) if so, the details thereof and if not, the reasons therefor?

MINISTER OF THE AND INFORMATION BROADCASTING (SHRIMATI SUSHMA SWARAJ): (a) and (b) Budgetary support to Prasar Bharati is being provided to meet its expenditure after due scrutiny and examination of its various requirements. The Prasar Bharati Act as it exists does not provide for any day to day monitoring. However, Prasar Bharati are subject to the usual monitoring and review of relevant Parliament Committee and audit.

(c) and (d) Action has been initiated in this regard both by the Government as well as Prasar Bharati.

Proposals for Programmes on Second Channel of Doordarshan

VIIAYA 3795. SHRI RAGHAVAN: Will the Minister of AND INFORMATION BROADCASTING be pleased to state:

- (a) the details regarding the proposals second channel of usc the Doordarshan exclusively for the telecast of the programmes of the States;
- (b) whether Government will consider such a suggestion;
- (c) which are the States which gave starting second for representations channel: and
- (d) the details of the action taken in this regard?

THE MINISTER OF INFORMATION AND BROADCASTING (SHRIMATI SUSHMA SWARAJ): (a) to (d) While there is no proposal to use Second Channel of Doordarshan exclusively for telecast of the programmes of the States. Kendras originate Doordarshan programmes in their respective Regional Language between 14.30 hrs. to 20.30 hrs. (very recently this has been increased by two hours in each Kendra of Doordarshan). Regional Service gives a complete package of programmes to viewers in each language of the State. Besides this, regional programmes are also telecast under the Regional Language Satellite Service (RLSS) and such programmes can be seen throughout the country with the help of an appropriate dish antenna system. No repersentation from the States for starting second channel has been received by Prasar Bharati.

Objections of Law Ministry on Plans for Uplinking from India

Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

- (a) whether the Law Ministry has raised objections against Government's plan to allow private domestic TV channels to uplink from India;
 - (b) if so, the reasons therefor; and
- (c) the details of the proposed uplinking facilities to be provided from the country?

THE MINISTER OF INFORMATION AND BROADCASTING (SHRIMATI SUSHMA SWARAJ): (a) No, Sir.

- (b) Does not arise.
- (c) The Government have already approved the following scheme:—
 - (i) The Indian satellite channels which are presently uplinking from abroad and are taking foreign exchange release for this purpose, would be permitted to uplink their from programmes Indian through Videsh Sanchar Nigam Ltd. Only Indian satellite channels who hold Indian equity of at least 80% and effectively manged by resident Indians. would considered for this purpose.
 - (ii) Indian satellite channels would be initially permitted to uplink their TV channels to both Indian as well as foreign satellites.

- (iii) permission for uplinking by Indian satellite channels would be restricted to TV signals only.
- (iv) The applications would be made to the Ministry of Information & Broadcasting. On the basis of 'No Objection' certificiate issued by this Ministry, the final approval and licence would be given by the Wireless Planning adviser (WPA) in the Department of Telecommunications subject to the usual terms and conditions and payment of licence fee and royalty etc.
