Secretary has been constituted to sort out coordination problems and genrerate consensus amongst the Department with a view to facilitate the growth of tourism.

Promotion of Tourism

3980. SHRI LAJPAT RAI: Will the Minister of TOURISM be pleased to state:

THE MINISTER OF STATE IN THE MINISTRY OF **TOURISM** OMAK APANG): (a) The steps taken by the Union Govtmment for the promotion tourism include improvement of infrastructural facilities and tourism product by providing fmancial assistance Governments, State encouraging to private investment, undertaking Promotion and Publicity and Human Resourced Development.

(b) Development of Tourism is primarily undertaken by the State Governments/UT Administrations. The Ministry of Tourism provides financial assistance to the state Governments/UT administrations improving the facilities and attractions at various destinations on the basis of specific proposals received from them. The Ministry of Tourism also commissions surveys and studies and advise the State Governments. During 1997-98, based on the State's performance, the Ministry of Tourism, Govt of India sanctioned financial assistance to Punjab, Uttar

Pradesh and Madhya Pradesh as per details given below:

पर्यटक मंत्रालय में राज्य मंत्री (श्री ओमाक अपांग):

- (क) जी हां। अर्धकृम्भ पर्व/मेले में शामिल होने के लिए हरिद्वार जाने की इच्छुक दो इतालवी पर्यटकों को दिल्ली के ट्रेवल एजेंटों द्वारा यह कह कर कश्मीर भेज दिया गया कि पर्व/मेले का स्थान उत प्र. में कथित दंगे के कारण बदल दिया गया है। मामले को पुलिस में दर्ज कराया गया है तथा असदुल्ला पुत्र जफ्पर निवासी-डल लेक, नेहरु पार्क, श्रीनगर को गिरफ्तार किया किया गया है। इस बात के कोई प्रमाण नहीं है कि पुलिस कार्मिक और टैक्सी आपरेटर्स भी इस मामले में शामिल

Foreign and Private Investment in **Tourism**

SHRI **SOLIPETA** RAMACHANDRA REDDY: Will the Minister of TOURISM be pleased to

- (a) the steps taken to attract foreign and private investment in tourism to boost tourism; and
- (b) the negotiations proposed with travel agents association of India for developing and propagating destinations?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM (SHRI OMAK APANG): (a) Government of India has identified tourism as a high priority industry for foreign investment. Consequently a Foreign Investment Promotion Board and a Project Approval Board has been set up by the Government in order to clear proposal for foreign investment expeditiously. Further, foreign investment upto 51% and NRI investment upto 100% alongwith foreign collaboration in respect of technical consultancy services, franchise, management fee are under the automatic approval scheme under which such (proposals are cleared by RBI itself.

(b) There is a regular dialogue between the Ministry of Tourism and Travel Agent Association/Tour Operators/ Hoceliers for developing and promoting Tourism destinations in the country.

Facilities to Low Budget Tourists
