Centres/Quality Dyeing Units, Project Package, Thrift Fund, New Insurance Scheme, Margin Money for Destitute weavers. Loan to State Governments and Market Development Assistance Scheme to Uttar Pradesh. All State Governments including Uttar Pradesh have been advised to take optimal advantage of these schemes.

### Profits/Losses of NTC Units

# 3969. SHRI GOVINDRAM MIRI: SHRI RAGHAVJI:

Will the Minister of TEXTILES be pleased to state:

- (a) tlie details of profits/losses incurred by each of the NTC units during the preceding three years, year-wise;
- (b) the causes for losses, if any, incurred and when; and
- (c) the steps taken/contemplated to be taken by Government to make them profitable?

THE MINISTER OF TEXTILES (SHRI KASHIRAM RAN A): (a) Details of profit/losses incurred by each NTC Unit during the last three years year-wise are given in Annexure [See Appendix 184, Annexure No. 981

- (b) The NTC Mills have been incurring losses due to various reasons which include, inter-alia, obsolete machinery, excess man power, acute shortage of working capital, and lack of modernisation.
- (c) On the basis of a unit wise viability study made by NTC, Government is considering a revised turn around strategy for the viable mills of NTC, keeping in view the BIFR norms of the net worth of these mills turning positive, within the period prescribed by BIFR. The interest of the workers will be kept in view in the revival plan.

# Growth in garment export

- 3970. SHRI S. NIRAIKULATHAN: Will the Minister of TEXTILES be pleased to state:
- (a) whether it is a fact that out of the total Government support for export during 1997-98, only 11 per cent support was given to garment sector;
- (b) if so, whether it is a fact that the export in garment sector registered only negligible growth in export during that period; and
- (c) what are the reasons for the poor growth?

THE MINISTER OF TEXTILES (SHRI KASHIRAM RANA): (a) and (b) Government support to the garment sector covers neutralisation of taxes, Export Promotion Schemes, Export Import (EXIM) Policy etc.

During 1997-98 exports of garment registered a growth of 3.1% in US dollar terms and 10% in Rupee terms.

(c) The low growth is due to the sluggishne in the overseas markets particularly in the EU.

### **Production of Muga Silk**

# 3971. SHRI PARAG CHAUHA: SHRI GOVINDRAM MIRI:

Will the Minister of TEXTILES be pleased to state:

- (a) the total production of Muga Silk in the country during the preceding three years. State-wise;
- (b) whether certain environmental diseases are posing threats to Muga silk production in the North-East;
- (c) if so, the steps taken by Government to solve the problem; and
  - (d) the details thereof?

THE MINISTER OF TEXTILES (SHRI KASHIRAM RANA): (a) Statewise Muga raw silk production during the last three years is given below. The figures for 1997-98 are provinsional subject to reconfirmation by the concerned State Governments.
