#### **New Exploratory Wells in Krishna-Godavari Basin**

4101. DR. Y. LAKSHMI PRASAD: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

(a) whether the Oil and Natural Gas Corporation plans to drill more exploratory wells in Krishna-Godavari basin;

(b) if so, the details thereof; and

(c) by when the oil and gas expected to be extracted from the new wells?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SANTOSH KUMAR GANGWAR): (a) and (b) Yes Sir. During the year 1998-99, 27 exploratory wells are planned to be drilled in the Krishna-Godavari basin.

(c) The production from the new wells would depend upon the results of exploratory drilling and development of infrastructure.

#### **Revision of Crude Oil Production Target**

4102. SHRI RAJNATH SINGH 'SURYA': Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

(a) whether it is a fact that Government have revised the crude oil production target; and

(b) if so, the details thereof, alongwith the reasons for doing so?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SANTOSH KUMAR GANGWAR): (a) and (b) The Crude Oil Production target for the year 1998-99 has been set at 34.72 MMT. The projections of crude oil production during the 9th Plan have been raised from 180.80 MMT to 184.80 MMT
