and State (c) The Central have taken several Governments measures to facilitate primary education of children, including those belonging to SCST. These relate to increased access to schools, improvement in school infrastructure. incentives for SC/ST students and girls such as free textbooks. uniforms and attendance scholarships, implementation of Mid-day Programme and residential schools and hostels for SC/ST boys and girls;

District Primary Education Programme (DPEP), which is being implemented in 149 districts, have designed contextually relevant strategies to ensure better participation and retention of children at primary level.

Percentage of literacy among adivasi women

- (a) the percentage of literacy among the Adivasi women in the country, particularly in the States of Bihar, Uttar Pradesh and Madhya Pradesh;

THE MINISTER OF HUMAN RE-(DR. SOURCE DEVELOPMENT MURLI MANOHAR JOSHI): (a) The female literacy rate of Scheduled Tribes as per 1991 Census, is as follows:--

All India 18.19% 14.75% Bihar Madhya Pradesh 10.73% Uttar Pradesh 19.86%

(b) and (c) The Total Literacy Campaign (TLC) is the principal strategy of National Literacy Mission for eradication of illiteracy in the country. The literacy compaigns cover the entire illiterate population in 15-35 year age-group irrespective of their caste, creed or sex. Scarce resources, difficult terrain, scattered population, inacessability to schools, lack of literacy tradition and gender bias against women could be attributed as major impediments for literacy

drive among women, inspite of which literacy camapigns have been launched covering tribal population in various parts of the country.

Sixty percent of learners covered under literacy programs are women.

No Committee to further monitor such admissions has been composed.
