Superfast trains presently running between Delhi and Andhra Pradesh

4273. SHRI P. PRABHAKAR REDDY: Will the Minister of RAILWAYS be pleased to state:

(a) the number of superfast trains presently running between Delhi and Andhra Pradesh;

(b) whether keeping in view the increase in the demand from passengers, it is proposed to start another superfast train or a Rajdhani Express; and

(c) if so, the details thereof and if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS AND THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND MINISTER OF STATE IN THE MINISTRY OF PLANNING AND PROGRAMME IMPLEMENTATION: (SHRI RAM NAIK): (a) At present, besides 3 pairs of Rajdhani, 6 pairs of superfast trains are available between New Delhi/Nizamuddin and Andhra Pradesh.

(b) There is no such proposal at present.

(c) Due to operational difficulties and resource constraints.

Water shortage in the retiring room at Gurwayour

4272. SHRI N. THALAVI SUN-DARAM: Will the Minister of RAILWAYS be pleased to state:

(a) whether it is a fact that in the Railway retiring room in Gurwayour there is always water shortage and it is not worth staying in the retiring room;

(b) whether it is fact that Gurwayour municipality supplies the water to retiring room but it is not sufficient; and

(c) whether there is any proposal to put a bore in the Gurwayour railway station and also to modify or renovate the retiring room?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS AND THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND THE MINISTER OF STATE IN THE MINISTRY OF PLANNING AND PROGRAMME IMPLEMENTATION SHRI RAM NAIK:

(a) to (c) There is shortage of water supply in Gurwayour from Kerala Water Authority during summer months. However, water supply at Gurwayour station including the retiring rooms available there, is being managed with well-water available with Railways. This year there is no proposal for provision of a tube well

or to modify/renovate the retiring room at Gurwayour station.

Progress of Trichy-Chennai B.G. line in Tamil Nadu

(a) the progress of Trichy-Chennai Broad Gauge in Tamil Nadu as on date, and the year by which the line is expected to be completed and opened for traffic; and
