Handing over the PDS to Panchayats and Municipalities

- 4176. SHRIMATI **URMILABEN** CHIMANBHAI PATEL: Will the Minister of FOOD AND CONSUMER AFFAIRS be pleased to state:
- (a) whether Government have decided to hand over the PDS to Panchayats and Municipalities at local level;
- (b) whether Government are examining the possibilities of handing over the PDS to Gram Samities specially organised for the purpose;
- (c) whether any State Governments have eiyjerimented on an experimental basis or as a pilot project for the system expressed in (b) and (c) above: and
- (d) if so, what is their experience and if not, whether Government intend to do so?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD AND CONSUMER AFFAIRS (SHRI SATYA PAL SINGH YADAV): (a) and (b) No, Sir.

The implementation of Public Distribution System is the joint responsibility of Central and State Governments. While the Central Government is responsible for procuring and making avilable, at affordable prices, PDS commodities to the States/UTs, the operational aspects of further distribution to the consumers under the PDS, including management of Fair Price Shops(FPS), are matters under the administrative jurisdiction of the State Government/UT Administration.

The issue of entrusting the management of Fair Price Shops (FPS) to the elected Panchayats and Nagar Palikas was discussed in the Conference of Chief Ministers on Basic Minimum Services held on July 4th and Sth, 1996 in New Delhi. The Conference felt that the actual running of the FPS by the elected Panchayats and Nagar Palikas need not be insisted uponl

(c) and (d) The State Government of Orissa have reported that they have ta-

ken a decision to give priority to Gram Panchayats in appointment of retailers undec PDS and distribution of rate at Rs. 2/- per kg. to BPL families and at Rs. 4/ - Per kg. to BPL families through Gram Panchyats is running satisfactorily.
