The State of Rajasthan ranks second from the bottom, above the State of Bihar, in the list of States and Union Territories.

Wages of Anganwadi Workers

- (b) The Anganwadi Workers are paid honorarium which ranges between Rs. 438/- and Rs. 563/p.m. depending on their educational qualifications and length of honorary work. The helpers are paid a fixed honorarium of Rs. 260/-p.m. Various representations have been received for declaring them as Government employees.
- (c) Honorarium was last revised w.e.f. 16.5.1997.

The boarding the lodging charges for attending training programmes is also under process of upward revision.

They are voluntary workers. There is no proposal to declare them Government employees.

Teacher-student Ratio in Training College
