Measures for Environnicntal Protectkm in the North-Eastern Region

- 4146. SHRI W. ANGOU SINGH: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:
- (a) the measures taken up for environment protection in the North-East region;
- (b) the amount of assistance so far released for this scheme on State-wise basis; and
- (c) the number of States where the State Pollution Control Boards have been created?

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI BABU LAL MARANDI): (a) Under the Water (Prevention & Control of Pollution) Act, 1974 and the Ah (Prevention & Control of Pollution) Act, 1981, the responsibility of monitoring and control of poUuition is primarily entrusted to the State Pollution Control Boards. The concerned State Pollution Control Boards in the North-Eastern Region are required to take necessary action for prevention and control of pollution. The North-Eastern State Pollution Control Boards have taken up the following programmes for assessment and prevention and control of pollution:

- (1) Inventorization of industries and assessing pollution potential from the industries.
- (2) Assessment of water quality of rivers and lakes.
- (3) Assessment of vehicular pollution and assessment of ambient air quality.
- (4) Proper collection, transportation and disposal of municipal solid wastes.
- (5) Preparation of zoning atlas for siting of industries taking environmental factots into consideration.
- (b) The Ministry of Environment & Forests and the Central Pollution Control Board have been providing necessary financial and technical assistance to the North-Eastern State Governments and State Pollution Control Boards for picvcmion and control of pollution. Approximate figures regarding financial assistance provided to the States and State Pollution Control Boards located in the North-Eastern region during the last couple of years are as under:

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI BABU LAL MARANDI): (a) Yes, Sir.

(b) So far figures of estimation of tiger and panther population, made in 1997, has been received from 11 States only. These figures are given in the Statement (See below). The figures are yet to be reviewed by the Steering Committee of Project Tiger.

For lions, the estimation is conducted once every five years. The population of lion as per the 1995 estimation was 304.
