## Survey for gauge conversion of Bharuch-Vishawamitri rail line

- 4261. SHRI AHMED PATEL: Will the Minister of RAILWAYS be pleased to state:
- (a) whether the survey for gauge conversion of NG line of Bharauch-Samni-Jambusar-Vishwamitri in the State of Gujarat has been completed;
- (b) if so, by when the gauge conversion work on the said line will be started;
- (c) whether funds have been earmarked for the work; and
  - (d) if so, the details thereof?

## Closing of Approach Roads For Anand Vihar Railway Station

- (a) whether Government are aware that both the approach roads for Anand Vihar Railway station are being closed by means of installing iron gates thereon resulting a lot of inconvenience/difficulties to commuters:
- (b) whether these activities are being done in connivance of Railway authorities to prepare the ground for shifting the existing platforms some 200-300 mts. towards Tilak Bridge on the plea of approach roads; and

- (c) what action have been taken to remove the iron gates and turn down the proposal of shifting the platform as proposed by technical team of the Ministry? ## Escalators in Calcutta Metro Stations

- (a) the number of escalators installed and in operation at the different stations of the Calcutta Metro System,
- (b) whether net earnings of the metro system are not inhibited because of the lack of a larger number of escalators; and
