Regularisation of Services of Employees of National Nutrition Monitoring Bureau, Nagpur

- (a) whether employees working in the National Nutrition Monitoring Bureau, Nagpur and other similar units in India which 'comes under I.C.M.R. are not regularised even though the establishment is in existance for mord than two decades; .
- (b) whether representations were made tu the Minister of Health by the staff and also by Member of Parliament from time to time for regularisation of the staff and establishment;

- (c) whether Supreme Court has also decided and directed for regularisation of such establishments and the staff; and
- (d) by when the decision to regularise the establishment a'nd the staff is likely to be

THE MINISTER OF STATE OF THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI DALIT EZHILMALAI): (a) to (d) The question of grant of permanent status to some of the mega extra-mural projects set up by ICMR, including NNMB, Nagpur and regularisation of employees working in them, has been receiving attention of the Government. Representations from staff associations as also the Members of Parliament have been received in this regard. To examine the issues, a Committee under the Chairmanship of Dr. Harcharan Singh was set up by the ICMR. The recommendations made by this Committee were placed before the Scientific Advisory BoaTti (SAB) of the

Consequent to the decision taken by SAB, these recommendations were examined by Dr. Sub-Committee. Rudrappa recommendations of this Committee arc to be considered by SAB-Governing Body of the Council. A decision on the recommendations of Dr. Rudrappa Sub-Committee will be taken by the Government after the Scientific Advisory Board/Governing Body have considered the issue.

There is no specific Supreme Court Ruling about permanency of .such establishment 8t regularisation of their staff. The ICMR has, however, received a copy of the judgement. of Supreme Court on pension on temporary Government Servants given on 20.9.95 in Ovil appeal No. 8409 of 1995. This ruling/order is only applicable temporary Govt, servants.
