UGC Recommendations Regarding Pay Scales of College Teachers

- (a) whether the University Grants Commission (UGC) has submitted its recommendations on the revision of scales of college teachers to the Government;
- (b) if so, the details of the recommendations made by UGC;
- (c) why the Government has not implemented the recommendations so far: and
- (d) by what time they are likely to be implemented?

MINISTER OF HUMAN THE RESOURCE DEVELOPMENT (DR. MURLI MANOHAR JOSHI): (a) to (d) In August, 1994, University Grants Commission (UGC) had constituted a Pay Review Committee under the Chairmanship of Prof. R.P. Rastogi, former Vice-Chancellor, Banaras Hindu University, to examine the present structure of emoluments and conditions of service of teachers in Universities and Colleges and to make recommendations in this behalf for improving the quality of education. The Committee submitted its Report to the Commission in May, 1997, which was accepted by it in its meeting on June 13, 1997. The Committee thereafter, submitted its views again in December, 1997. After considering the recommendations of the UGC the Government, in April' 98 announced certain pay structure for the teachers of universities and colleges. However, the Government received representation from the various teachers' Organisations against the announced pay structure as also certain directions from the Delhi High Court for a reconsideration. The final decision is likely to be announced shortly.
