Fall in Production of Edible Oils

- 4167. SHRI K. KALAVENKATA RAO: Will the Minister of FOOD AND CONSUMER AFFAIRS be pleased to state:
- (a) whether the production of edible oils fell from 250 lakh tonnes in 1996-97 to 237 lakh tonnes in 1997-98:
- (b) if so, the steps being taken to meet the shortfall; and.
- (c) the measures being taken to contain the recent spurt in the price of edible oils?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD AND CONSUMER AFFAIRS (SHRI SATYA YADAV): (a) The SINGH production of edible oilseeds, not edible oils, fell from 249.80 takh MTs in 1996-97 to 236.89 lakh Mts in 1997-98

(b) Some of the steps taken/being taken to augment the production of oilseeds, and hence of edible oils, to shortfall, are, providing meet the essential assistance through the oil-seeds production programme (OPP) of the Government of India to the States for production and distribution of quality plant protection measures including supply of plant protection chemicals and equipments, organising demonstration of advanced technology, assistance for oil palm development,

better incentives to producers through fixation of minimum support price of major oilseeds etc.

- (c) The important measures taken by the Government to contain the recent spurt in the price of edible oils are:
 - (i) Import of all edible oils barring coconut oil, palm kernel oil RBD palm oil and RBD palm stearing continue to be on OGL list.
 - (ii) Basic import duty of edible oils on OGL list has been reduced from 20% to 10% (the 5% surcharge remaining unchanged).
 - (iii) STC has been authorised to import 1.5 lakh MT of RBD palmolein for supply through PDS during August-November' 98
 - (iv) Government has decided to allow import of one million MT of sovabean.
 - (v) To improve the availability of mustard oil for direct consumption, the use of expeller mustard oil in vanaspati has been reduced from 30% to 10% maximum

THE MINISTER OF STATE IN THE OF FOOD AND MINISTRY CONSUMER AFFAIRS (SHRI SATYA PAL SINGH YADAV): (a) The names Sugar Mills which have been sanctioned financial assistance from the

Sugar Development Fund (SDF) tor modernisation/expansion during each of the last three years, State-wise are given in the Statement I (See below).

(b) and (c) The Mills which have been released both the instalments of their loan till date, are listed in Statement II (See below), while the Mills which have been disbursed only one instalment till date, are listed in Statement III (See below). The remaining nine Mills, which have been sanctioned loans from the SDF and have not been disbursed any instalment, are listed in Statement IV (See below).

After sanction of a loan, the Sugar Mills are required under the rules to complete considerable documentation before disbursement of the first instalment. Also, the loan is disbursed in two instalments—the second instalment being released only after due certification of full utilisation of the first instalment. Thus, there is a considerable gap between the date of sanction of the loan and the disbursement of the final instalment.

All the nine cases for which no disbursement has been made, were sanctioned loans in 1997-98. There has been no undue delay in the disbursement of these loans.
