## Quota system for distribution of Steel

4406, SHRI W. ANGOU SINGH: Will the Minister of STEEL AND MINES be pleased to state:

- (a) whether there is any quota system for distribution of steel in the country;
- (b) if so, the quantity of quota allotted to each State of North-East region; and
- (c) whether there is any concession for lifting the steel in the North-East States where there is no Railway head in the State?

THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINES (SHRI RAMESH BAIS): (a) after the decontrol of steel in 1992, there is no quota system for distribution of steel in the country except for 5 priority sectors vis: Defence, Railways, North East Region Exporters of Engg. Goods and the

Small Scale Industries Corporation (SSICS) of individual States for catering to the needs of SSI units in the States. To these designated priority sectors the Development Commissioner for Iron and Steel makes quarterly allocation of steel materials.

- (b) As per the demand projected by the Nodal authorities of States/SSICs of the North Eastern Region States, a supply plan/allocation is made by the Development Commissioner for Iron and Steel. Supply plan/Allocation made during 1997-98 is enclosed as statement See below).
- (c) There is no concession other than the rebate that is provided to State Small Scale Industries Corporations on lifting of steel against the allocation of BCI&S. At present the rate of rebate in respect of the North Eastern States is Rs. 550/- per tonne.
