

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS AND THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND THE MINISTER OF STATE IN THE MINISTRY OF PLANNING AND PROGRAMME IMPLEMENTATION (SHRI RAM NAIK): (a) and (b) The quinquennial surveys on employment and unemployment, conducted by National Sample Survey Organisation (NSSO), provide comprehensive data on employment and unemployment situation in the country. The latest such survey was conducted in 1993-94 (50th round). According to the information available from the latest NSSO survey, unemployment in the country as per Usual Principal Status (UPS), is estimated to be 9.0 million as on 1st January, 1994. This includes unemployment in the entire workforce pertaining to both organised and unorganised sectors.

(c) Separate targets for employment in organised and unorganised sectors are not fixed. The Eighth Five Year Plan envisaged 8 to 9 million average addition in employment opportunities per annum. During 1987-88 to 1993-94, the addition to employment as per UPS was 43.91 million. This implies an average addition of 7.3 million employment opportunities per annum.

(d) As on 1st January, 1994 the unemployment is estimated to be 9.0 million.

(e) Achievement of rate of growth of employment is crucially dependent on the overall growth in the economy and sectoral and sub sectoral pattern of growth. The rate of growth of employment observed during 1987-88 to 1993-94 covers only the initial two years of the Eighth Plan. During this period, sectors like Manufacturing, Mining & Quarrying; Construction and Community, Social & Personal Services registered a lower growth than the respective targets in the 8th Plan.

(f) The estimates for the Ninth Plan are not available.

(g) The approach to the Ninth Plan envisages priority to productive employment which will be generated in the growth process itself by concentrating on sectors, sub-sectors and technologies which are labour intensive, in regions characterised by higher rates of unemployment and under-employment.

#### **Money Stuck in Central Sector Projects**

The latest estimated cost of these 234 projects is Rs. 94042.5 crore.
